- ▶ Have assisted approximately 1500 Veterans

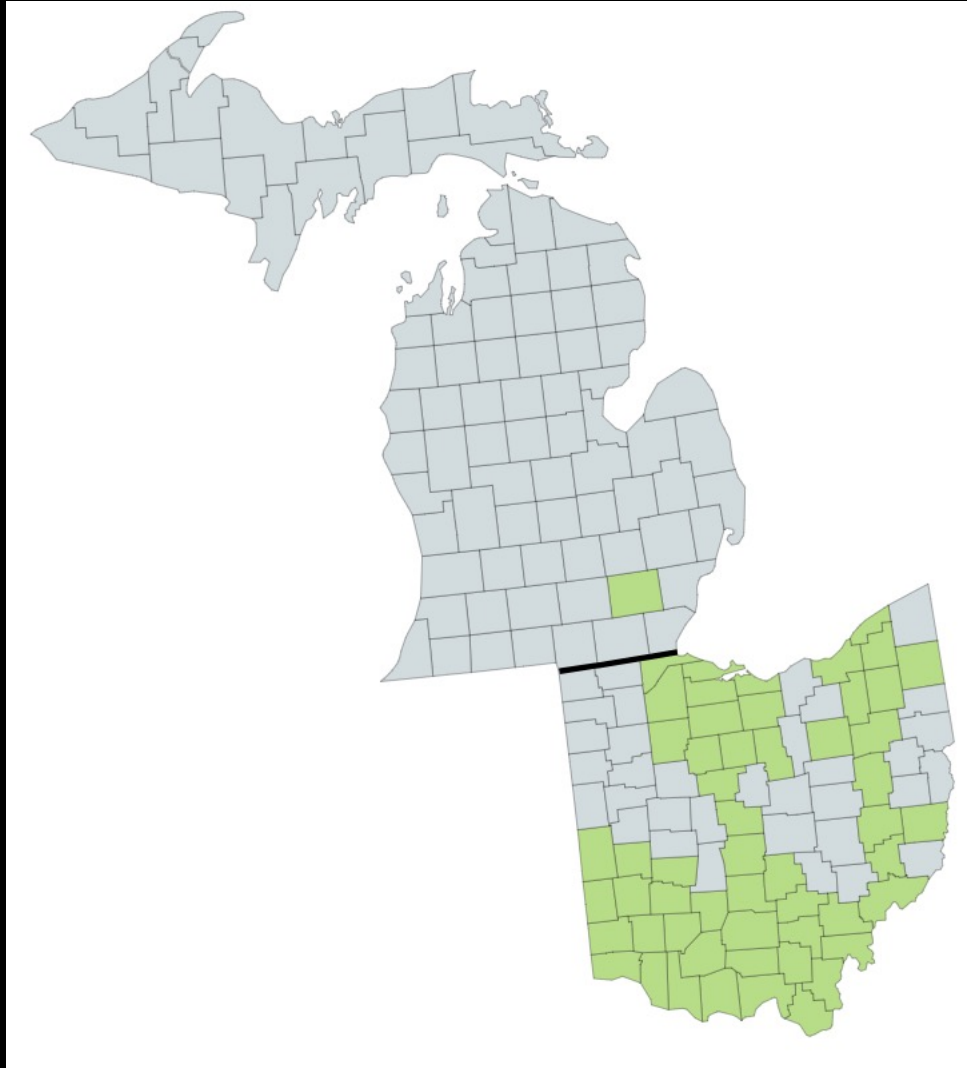

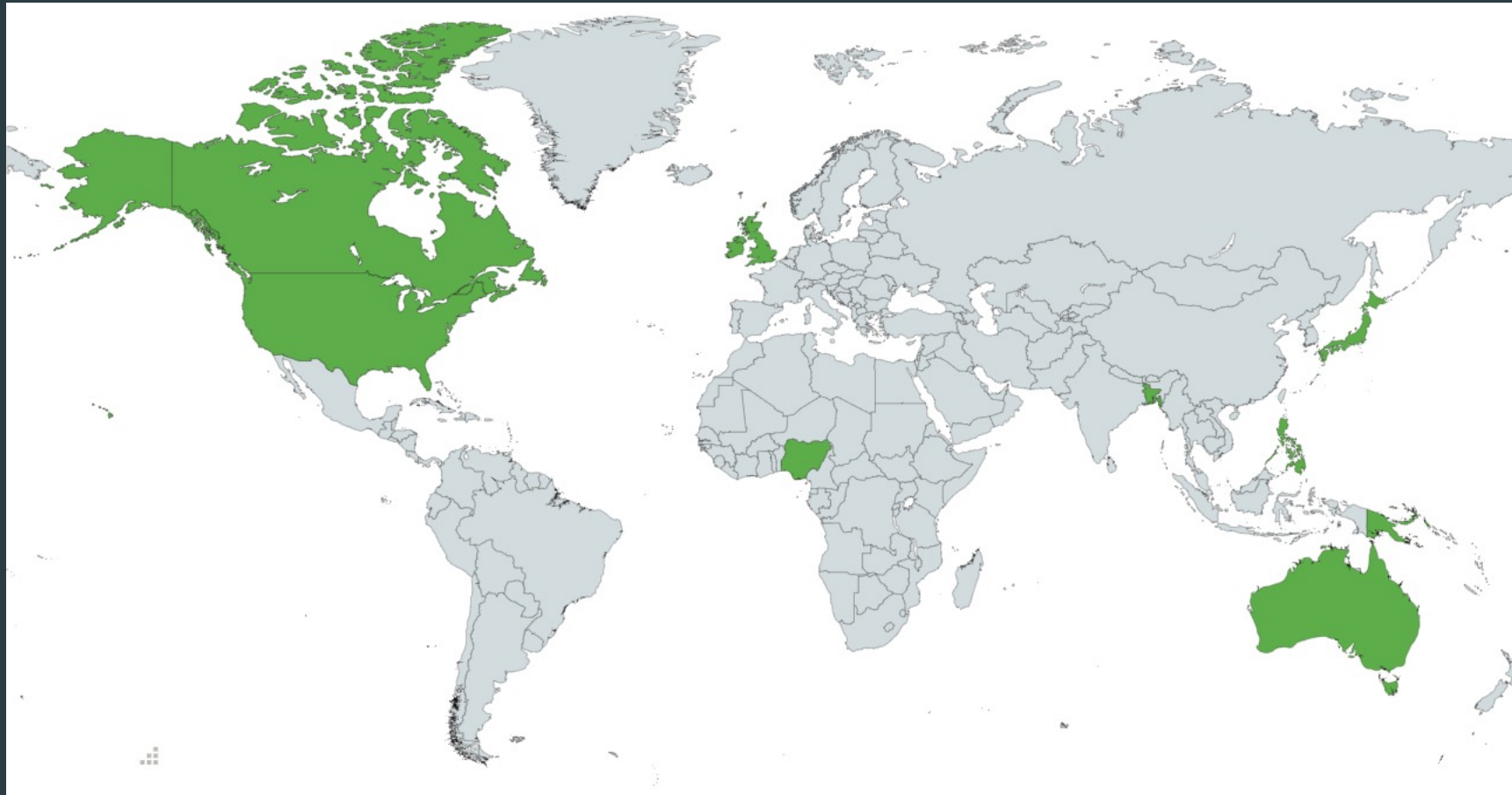

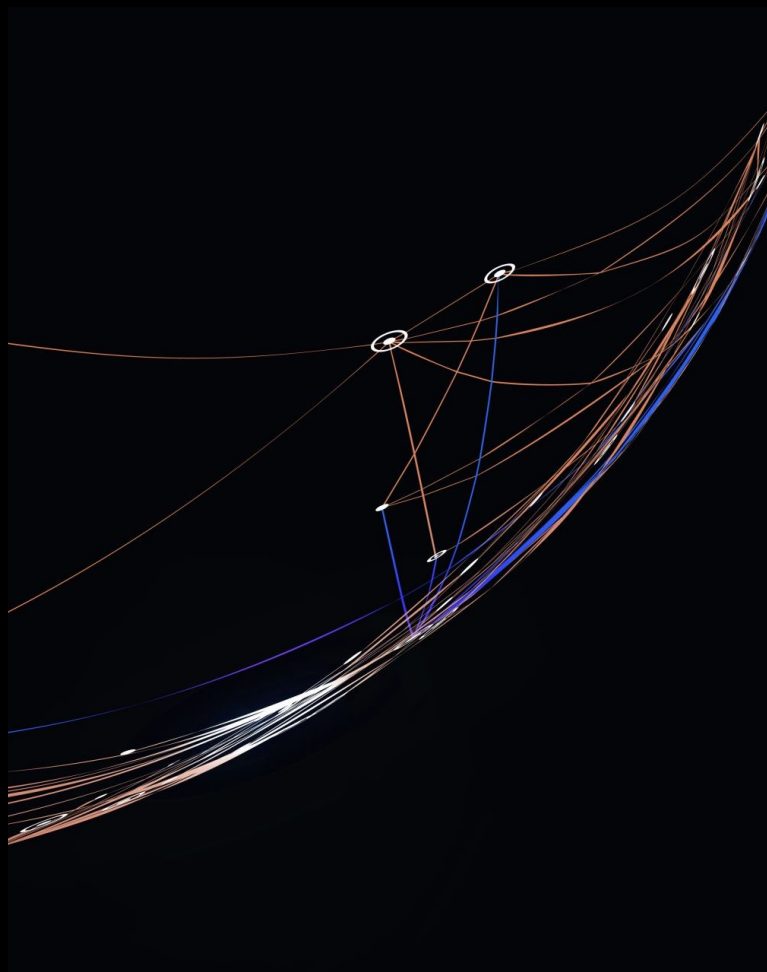
TRANSITIONAL ASSISTANCE: CARE PACKAGES

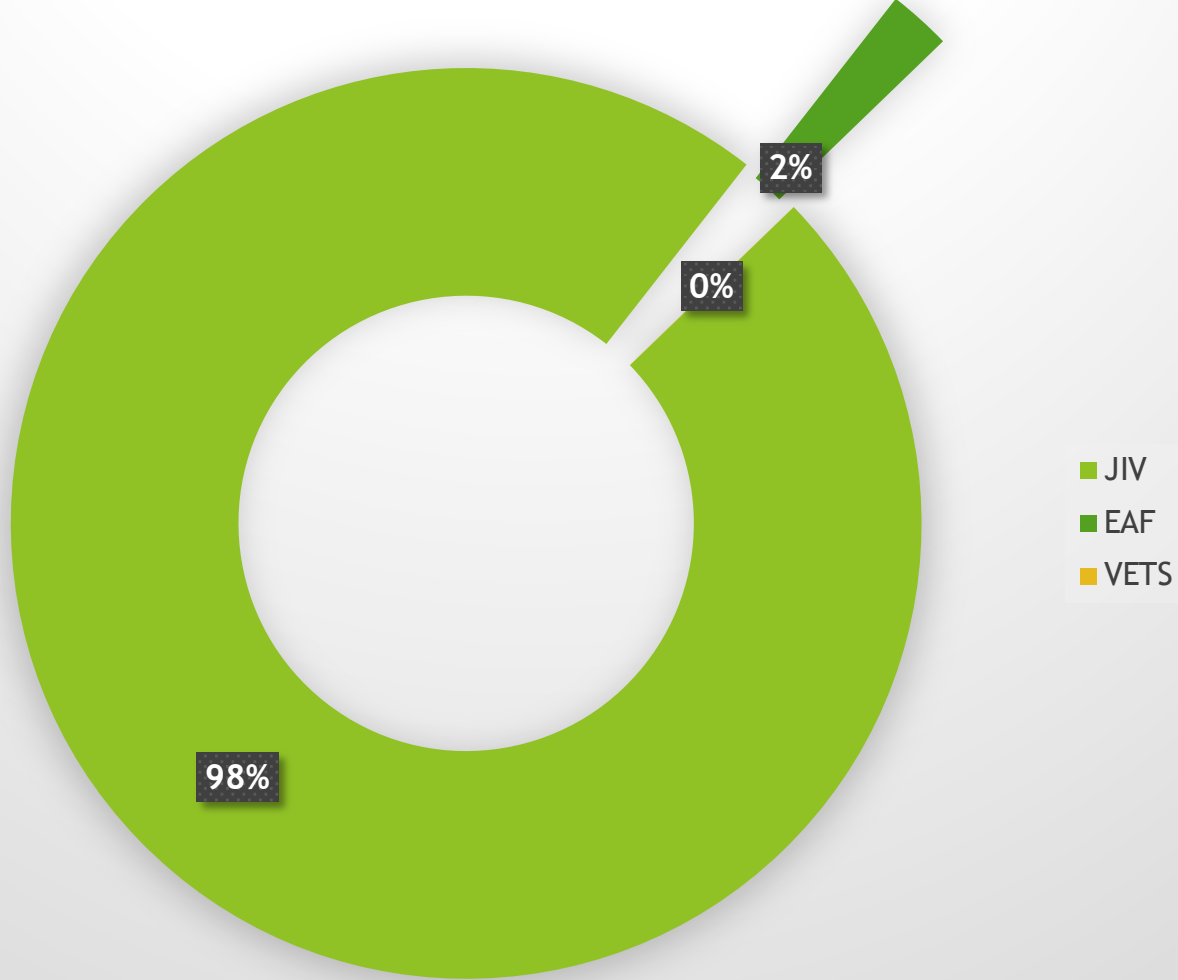

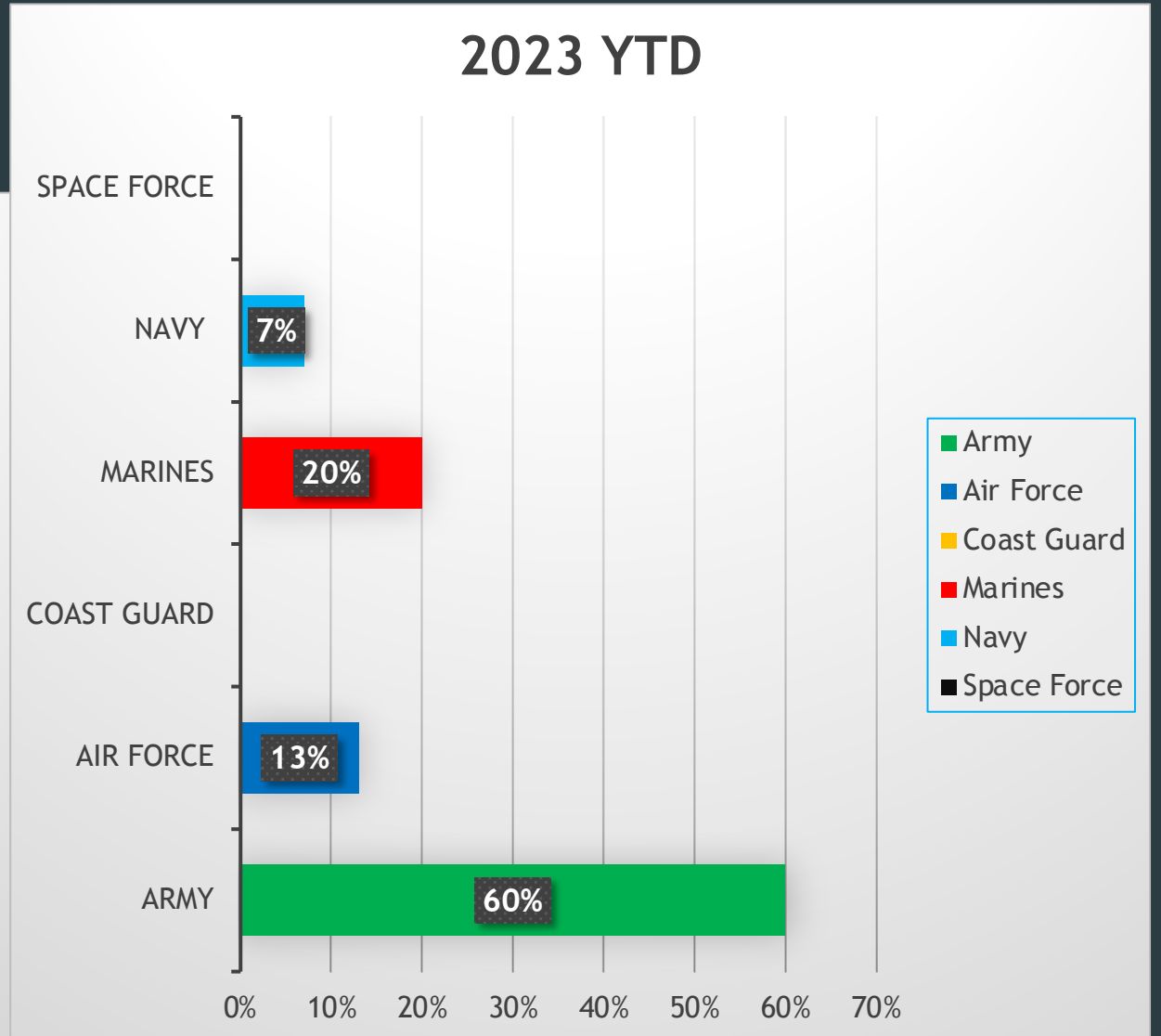
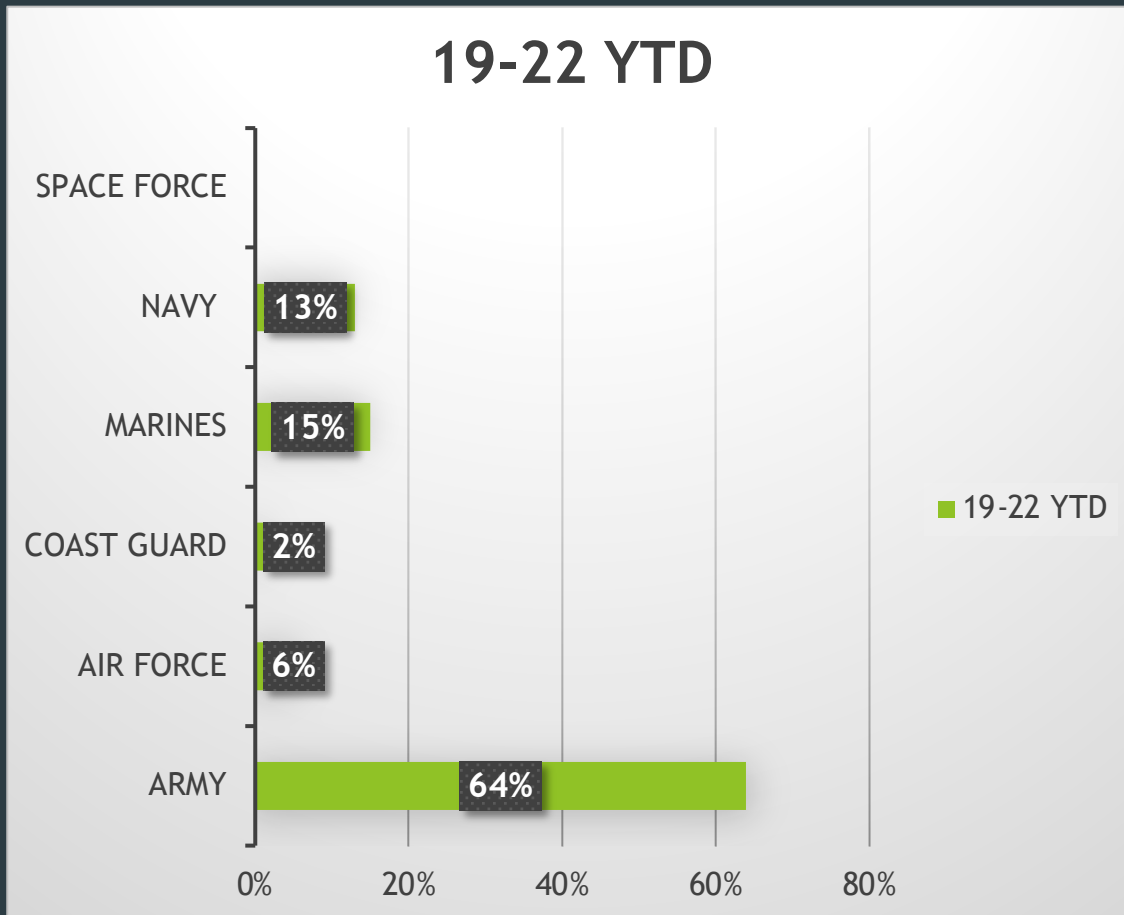

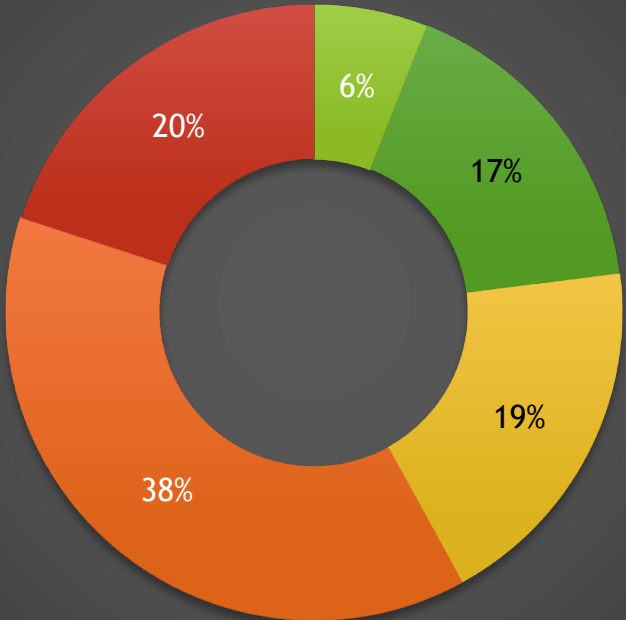


DATA POINTS: BRANCH OF SERVICE



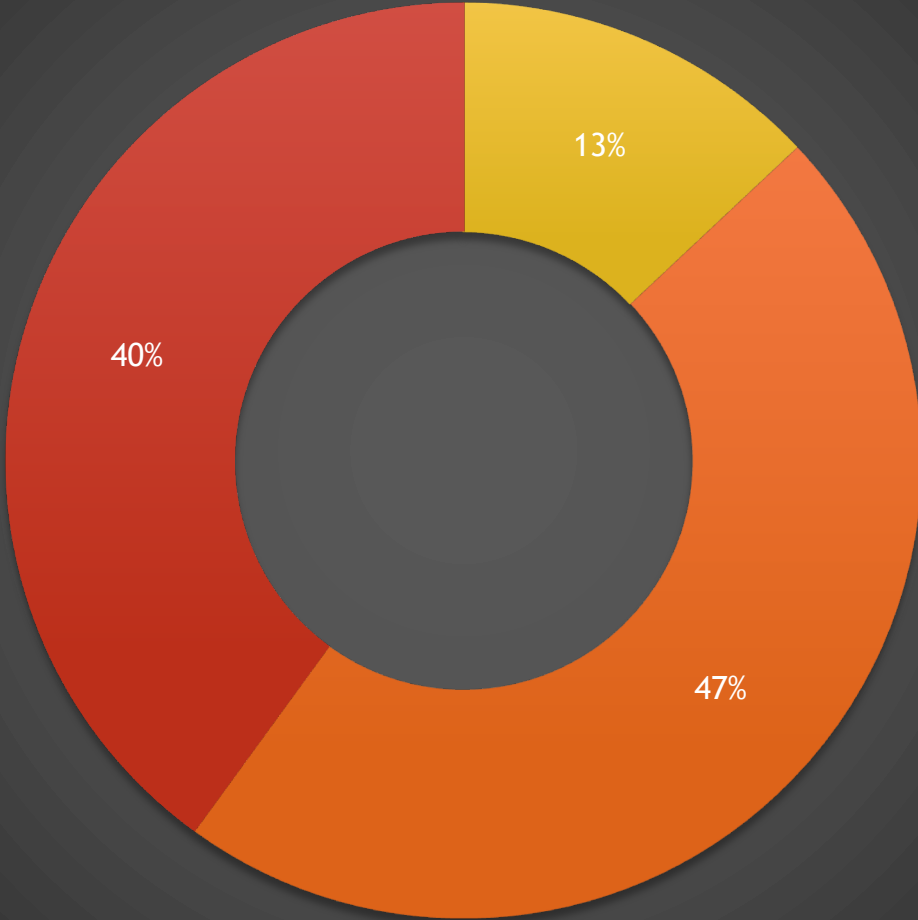
DATA POINTS: ERA OF SERVICE

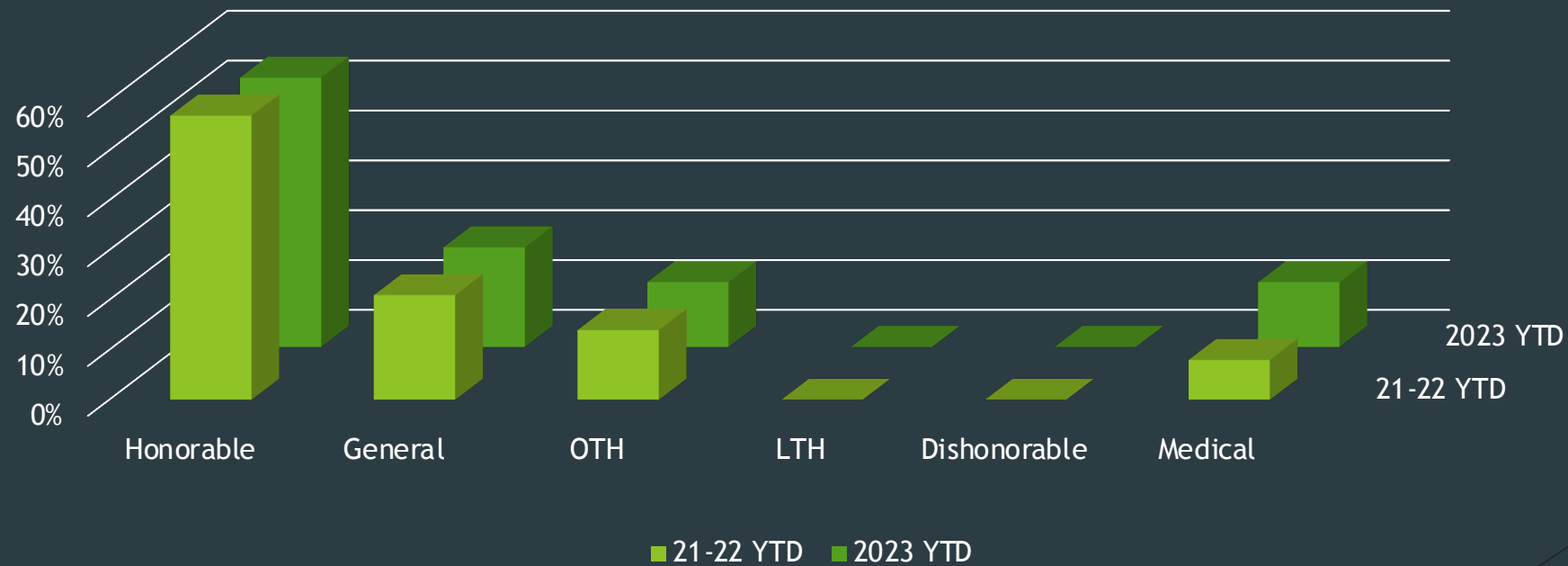

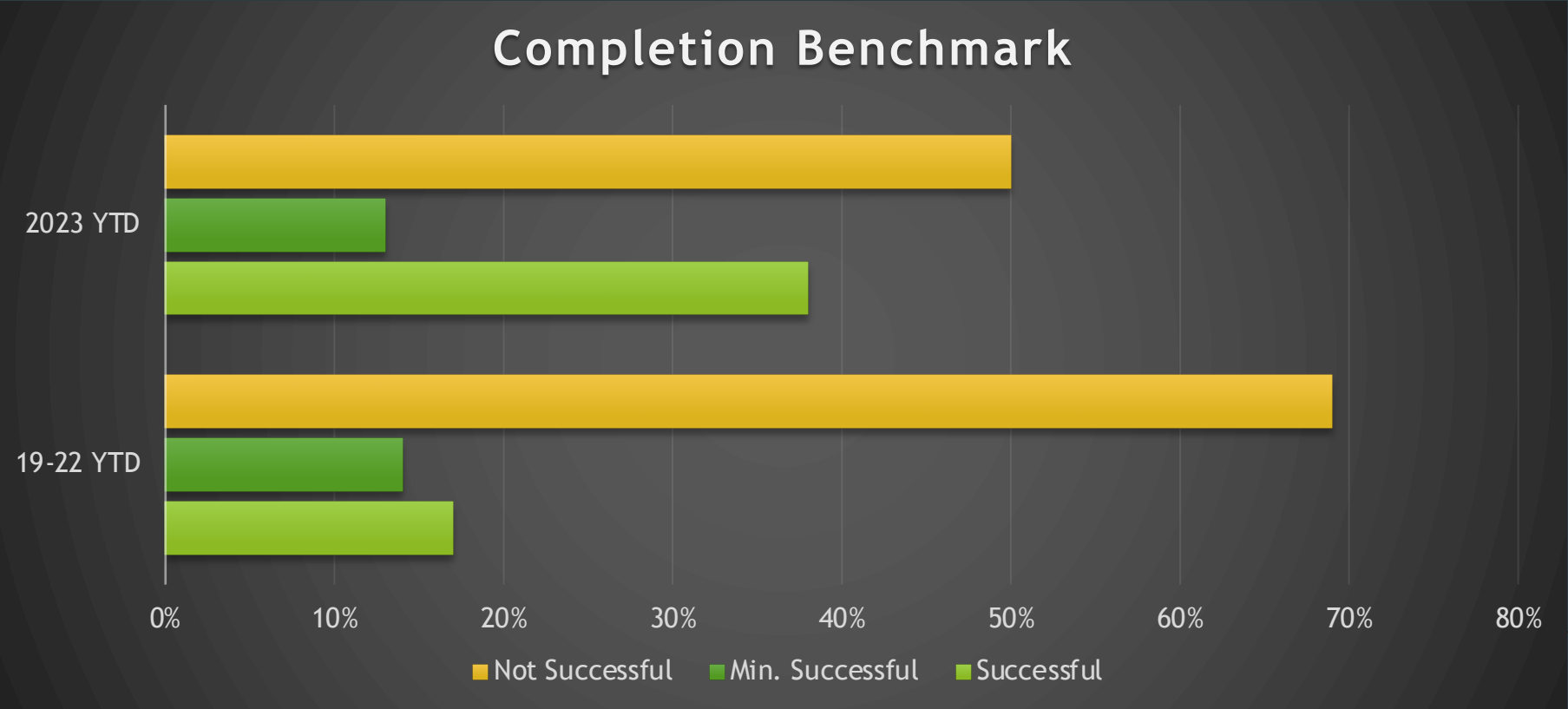

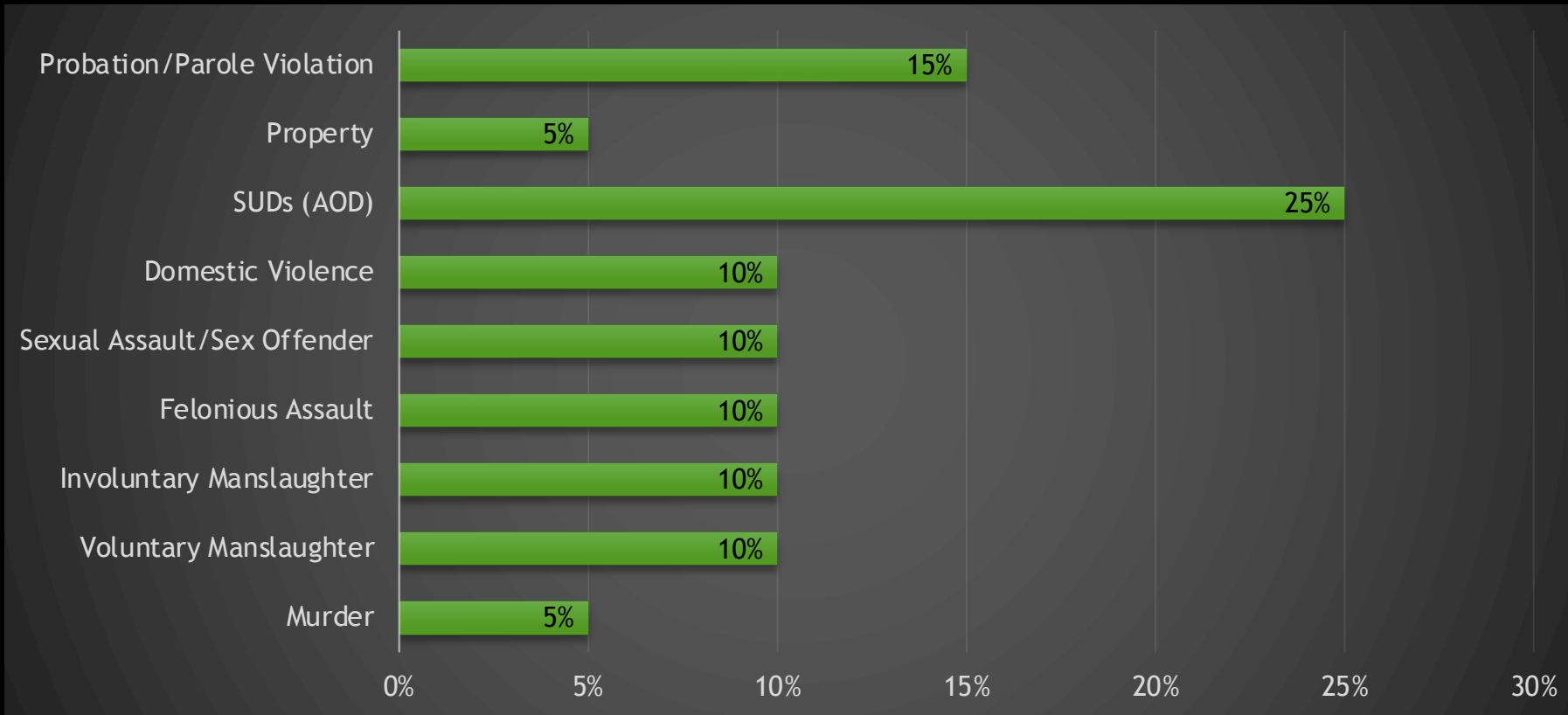

CRIMINAL CONVICTIONS



DATA POINTS: 2022-PRESENT (ADDITIONAL) -MENTAL HEALTH-

- ▶ 47% report a Mental Health Diagnosis
- ▶ 42% report using prescription medication
- ▶ 56% stated a primary diagnosis of PTSD
 - ▶ 33% reported Schizophrenia as a Secondary
 - ▶ 22% reported Bi-Polar, Anxiety, and/or Depression as a Secondary
- ▶ 67% report that a Mental Health diagnosis was given by Veteran Affairs
- ▶ 33% report that the diagnosis led to unfair treatment



DATA POINTS: 2022-PRESENT (ADDITIONAL) -SUDS-

- ▶ 74% report a Substance Use Disorder
 - ▶ 43% report drug-of-choice to be ALCOHOL
 - ▶ 21% report drug-of-choice to be METHAMPHETAMINE
 - ▶ 14% report drug-of-choice to be MARIJUANA and/or PRESCRIPTION MEDICATIONS
- ▶ 53% report they have been prescribed an opioid
 - ▶ Prescribed by PRIVATE medical professional: 30%
 - ▶ Prescribed by PUBLIC medical professional: 30%
 - ▶ Prescribed by MILITARY medical professional: 20%
 - ▶ Prescribed by VA medical professional: 20%
